**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF SANTA MARIA, CALIFORNIA
ESTABLISHING LIMITED TIME PARKING ZONES WITH
STREET SWEEPING SIGNAGE ON THE 700 BLOCK OF WEST
CYPRESS STREET AND THE 200–300 BLOCKS OF
SOUTH DEPOT STREET**

WHEREAS, it is in the best interest of the City of Santa Maria to establish limited time parking zones with street sweeping signage on certain streets within the City; and

WHEREAS, the City of Santa Maria Traffic Committee has reviewed and is recommending the establishment of limited time parking zones with street sweeping signage at the locations described below.

NOW, THEREFORE, IT IS HEREBY RESOLVED that pursuant to Section 7-5.14 of the Santa Maria Municipal Code, limited time zones with street sweeping signage shall be established on the following streets, incorporated herein by reference, at the following locations by the City Council of the City of Santa Maria, California, as follows:

- **West Cypress Street**, No Parking for Street Sweeping, Thursdays from 6:00 a.m. to 8:00 a.m., along the northerly curb face, beginning at the curb return of the northwest curb ramp of the intersection of West Cypress Street and South Depot Street and continuing 45 linear feet west to the driveway apron, then resuming after the driveway apron and continuing an additional 115 linear feet west.
- **West Cypress Street**, No Parking for Street Sweeping, Thursdays from 6:00 a.m. to 8:00 a.m., along the southerly curb face, beginning at the curb return of the southwest curb ramp of the intersection of West Cypress Street and South Depot Street and continuing 220 linear feet west.
- **South Depot Street**, No Parking for Street Sweeping, Thursdays from 6:00 a.m. to 8:00 a.m., along the westerly curb face, beginning at the curb return of the southwest curb ramp of the intersection of South Depot Street and West Church Street and continuing 275 linear feet south.
- **South Depot Street**, No Parking for Street Sweeping, Thursdays from 6:00 a.m. to 8:00 a.m., along the westerly curb face, beginning at the curb return of the southwest curb ramp of the intersection of South Depot Street and West Cypress Street and continuing 290 linear feet south.
- **South Depot Street**, No Parking for Street Sweeping, Fridays from 6:00 a.m. to 8:00 a.m., along the easterly curb face, beginning at the curb return of the southeast curb ramp of the intersection of South Depot Street and West Church Street and continuing 275 linear feet south.
- **South Depot Street**, No Parking for Street Sweeping, Thursdays from 6:00 a.m. to 8:00 a.m., along the easterly curb face, beginning at the curb return of the southeast curb ramp of the intersection of South Depot Street and West Cypress Street and continuing 290 linear feet south.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Santa Maria, California, as follows:

SECTION 1. The foregoing shall constitute traffic regulations pursuant to ordinance; and

SECTION 2. All work is to be accomplished using the standards and methods approved by the Director of Public Works/City Engineer. This shall be in accordance with standard City specifications, and the provisions of this resolution are to be carried out by erecting signs, painting marks and temporary markers and barricades required, and by such other indicators or devices as may be under provisions of the Vehicle Code of the State of California and regulations adopted pursuant thereto.

SECTION 3. The Chief Deputy City Clerk is hereby authorized to make minor changes herein to address clerical errors, so long as substantial conformance of the intent of this document is maintained. In doing so, the Chief Deputy City Clerk shall consult with the City Manager and City Attorney concerning any changes deemed necessary.
