12. PUBLIC HEARING

12.a Public Hearing and Approval of Water and Sewer Rates Commencing each January 1 from 2024 through 2027

The City Council conducted a public hearing and first reading to consider approving water and sewer rates commencing each January 1 from 2024 through 2027. Director of Utilities Shad Springer gave a presentation as detailed in the Council Agenda Report.

Public Hearing

Mayor Pro Tem Aguilera-Hernandez opened the public hearing at 6:44 p.m.

Jim Welch spoke in opposition to the water and sewer rate increase.

Having no more requests to speak, Mayor Pro Tem Aguilera-Hernandez closed the public hearing at 6:51 p.m.

Following the close of the public hearing, Assistant City Clerk Valadez reported that the City had 19,913 rate-payer accounts. 9,958 valid written protests were necessary to reach a majority protest of the water and sewer rates for 2024 to 2027, and only 5 were received prior to the meeting. No written protests were received during the public hearing. Therefore, no majority protest existed.
