

**RESOLUTION NO.**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SANTA MARIA, CALIFORNIA, AWARDING A BID TO MAIN LINE ENGINEERING, IN THE AMOUNT OF \$887,060, FOR THE CONSTRUCTION OF THE STOWELL-BLACK ROAD WATERLINE EXTENSION PROJECT, BID NO. 2023-13.**

**WHEREAS**, the City of Santa Maria formally advertised Stowell-Black Road Waterline Extension Project, Bid No. 2023-13 (“Project”); and

**WHEREAS**, the Notice Inviting Bids was published and posted in compliance with applicable sections of the Public Contract Code; and

**WHEREAS**, the bids were publicly opened at 2:00 p.m. on October 19, 2023; and

**WHEREAS**, Main Line Engineering, was determined to be the lowest responsive, responsible bidder who included all required documentation, bid bonds, and signatures; and

**WHEREAS**, in May 2023, an Initial Environmental Study was completed and based on the information available at the time of preparation of the plans and specifications, the Environmental Officer recommended that a Mitigated Negative Declaration be filed for the Stowell-Black Road Waterline Extension Project based on information contained in File SP2023-0004.

**NOW, THEREFORE, IT IS HEREBY RESOLVED** by the City Council of the City of Santa Maria, California, as follows:

1. The Mayor is hereby authorized and directed to execute, for and on behalf of the City of Santa Maria, an Agreement with Main Line Engineering, Inc., for the Stowell-Black Road Waterline Extension Project, Bid No. 2023-13; and
2. The award of the bid is conditional upon execution of the Agreement by the successful bidder in the form and terms set forth therein by the City; and
3. The City Manager, or designee, is hereby authorized and directed to designate funds from the following identified account: 002-011-080-52-47, “Stowell to Black Rd – Potable Water line” for the approved project; and
4. The City Manager, or designee, is hereby authorized to approve Contract Change Orders so long as expenditures do not exceed funding approved for the project; and

- 5. The Chief Deputy City Clerk is hereby authorized to make minor changes herein to address clerical errors, so long as substantial conformance of the intent of this document is maintained. In doing so, the Chief Deputy City Clerk shall consult with the City Manager and City Attorney concerning any changes deemed necessary.
